

DISABLED VETERAN'S HUNT 2019

Dear Fellow Veteran,

I'm excited you want to join us for the Annual Dan Fout Memorial Disabled Veteran's Hunt. We've had a great turnout and a wonderful time in past and hopefully this hunt will be even better. Plans are to accommodate 40 hunters with equipment, transportation to the hunting area, hunting blinds, meals, shooting competition and awards.

A drawing will be held on October 11th to determine the hunters selected for this year's hunt. I will notify all applicants by phone or email soon after the draw. I wish you luck in the draw but please understand that if you are not chosen it's only because I must keep the numbers at a manageable and safe level.

This year we are offering afternoon hunts on **October the 26 and 27** on the **Gabriel Farm at 28600 Kingston Pike, Circleville, Ohio**. These two days we will provide the things mentioned in the first paragraph. The hunt on **November 9** is an all-day hunt at Deer Creek State Park near Mt. Sterling.

On October 26 check in will be from **11:30 till noon**. You will be able to enjoy lunch and meet your guide. You may go to the range and shoot a couple practice arrows before the shooting competitions starts at 1:15. A pre-hunt meeting will take place at 2:15 and then we will load and take you to your hunting blind.

Legal hunting time ends around 7:00. We will bring you out of the woods at that time. When you get to "THE BARN" you will enjoy a great meal and program.

On Sunday plan to **arrive at the farm by 2:00**. We will load and transport you to the hunting area shortly thereafter. Once everyone is back after the hunt we will have a meal, a closing program and provide Deer Creek Information.

On November 9 we will meet at **0600** at the **Horseman's staging area** which is on the **road to the Deer Creek Lodge, 22300 State Park Rd, Mt Sterling, Ohio**. We will offer everything except shooting awards and an evening meal.

DIRECTIONS TO THE GABRIEL FARM

28600 KINGSTON PIKE CIRCLEVILLE, OHIO 43113

From Columbus:

Head south on Rt. 23 toward Circleville. **DO NOT GET OFF** on the Rt. 22/56, continue south to the **4th stop light (old BP station)** and **turn left on Tarlton Road**. Go to the **next stop sign, turn right on Kingston Pike**. Drive 3.4 miles, the farm is on the left a half mile south of the Pickaway Elementary School.

From the Chillicothe:

Heading north on Rt. 23, turn right at the **2nd stop light** (old BP station). Go to the **next stop sign, turn right on Kingston Pike**. Drive 3.4 miles, the farm will be on the left a half mile south of the Pickaway Elementary School.

From Lancaster:

Get on **Rt. 22 west** toward **Circleville**. As you approach Circleville turn **left on Rt. 56 (4th light)**, go to the **next light, turn right** onto **Kingston Pike**. Drive 5.5 miles, the farm will be on your left a half mile south of Pickaway Elementary.

From Athens:

Get on **Rt. 56 north** toward **Circleville** once you **cross Rt. 159**, drive 4 to 5 miles to the **stop sign (old BP Station)** and **turn left on Tarlton Road**. Proceed to the **next stop sign** and **turn left on Kingston Pike**. Drive 3.4 miles, the farm is on your left a half mile south of the Pickaway Elementary School.

From Washington Court House:

Get on **Rt. 22 east** toward **Circleville**. **Turn right on Rt 23 south**. Go to the **4th stop light** and **turn left on Tarlton Road**. Go the **next stop sign and turn Right** on **Kingston Pike**. Drive 3.4 miles, the farm is on the left a half mile south of Pickaway Elementary.
